## OFFICIAL RULES

1. **ELIGIBILITY:** Competition is open to all Las Vegas residents 18 years of older. Employees of Shucks Tavern, LLC are not eligible to enter.
2. **COMPETITION RULES:**
  - a. Must be 18 years of age or older.
  - b. Must present valid photo I.D.
  - c. Contestant must submit a completed registration form, signed release form and \$10.00 non-refundable registration fee (all at the same time) no later than 10PM Sunday, March 21, 2010 to any Shucks Tavern locations.
  - d. By submitting a registration form, entrant consents to Shucks Tavern, LLC using winners name, address, likeness and prize information in any and all promotional materials or media channels and waives their right to payment in such instances.
  - e. Competition begins sharply at 7PM Thursday, March 25<sup>th</sup>, 2010.
  - f. Contestants have no more than 45 minutes to completely clean their plates.
  - g. Official Contestants must be present no later than 6:30PM Thursday, March 25<sup>th</sup>, 2010 or will be disqualified from the competition.
  - h. Once competition has begun, contestant may not leave the table, including no restroom breaks.
  - i. No items from contestant's plate, burger or fries may be dipped into drinks.
  - j. Any contestant observed hiding their food, dropping it under the table or placing it on another contestants' plate will be disqualified.
  - k. Contestant must raise their hand after clearing their plate to notify a judge for inspection.
  - l. Winner must keep food down for a minimum of 2 minutes after their last bite to be declared the official winner.
  - m. Contestants who suffer from a "reversal of fortune" will be disqualified.
  - n. In the event of a tie, the judges will decide on the official winner.
  - o. First place winner will receive \$100.00 in cash, bragging rights and will be reimbursed their registration fee.
